

# Effective December 29, 2025, Hutchinson Aerospace & Industry Is CMMC Level 2 Certified

Cybersecurity is critical in today's defense industry, and Hutchinson Aerospace & Industry, Inc. remains committed to supporting the mission. The Department of Defense (DoD) launched the Cybersecurity Maturity Model Certification (CMMC Level 2) program to ensure that defense contractors and subcontractors maintain strong protections for sensitive data, including Federal Contract Information (FCI) and Controlled Unclassified Information (CUI). CMMC compliance will be mandatory for all select contracts that require the handling of FCI and CUI. While many manufacturers hesitated or hoped the CMMC compliance mandate would fade, Hutchinson took decisive action—and is now ahead of the game.

## The Problem: Escalating Cybersecurity Risks

As cyberattacks targeting intellectual property, defense technologies and supply chains escalate in frequency and sophistication, the U.S. government has responded with stricter security regulations. That means Hutchinson and other top defense contractors face increasing pressure, not only to develop next-generation technologies but also to safeguard the sensitive information that supports them.

Non-compliance with CMMC Level 2 puts this information at risk while jeopardizing a manufacturer's eligibility for future defense contracts. Recognizing this, Hutchinson took action immediately to become CMMC certified.

- Engaging a certified third-party CMMC expert for guidance and training
- Investing significantly in cybersecurity hardware and software
- Training every department, from engineering to sales, on CMMC principles
- Executing a complex, company-wide plan with discipline and rigor

The result? Hutchinson is certified CMMC Level 2, fully compliant, with a strong score and readiness for third-party certification.
